622-K-1401	ESF	5,534,000	NBAF will replace the 60-year-old Plum Island Animal Disease Center (PIADC) where USDA's Agricultural Research Service (ARS) and Animal and Plant Health Inspection Service (APHIS) currently conduct foreign animal disease research, testing and diagnosis. Expanding the mission of PIADC, NBAF is dedicated to the study of diseases that threaten both America's livestock industry and public health. As a next generation laboratory, NBAF is crucial to the protection of our nation's food supply, agricultural economy, and public health and safety. NBAF will drive significant gains in animal disease research and improve food and farm bio security's preparedness, resilience and risk reduction. NBAF will play a critical role in one health, a collaborative, multidisciplinary, and interdisciplinary approach with the goal of achieving optimal health outcomes, recognizing the interconnection between people, animals, plants, and their shared environment.
